III COMMITTEE REPORTS

Work Force Development

Food Safety

The agreed to investigate the grant from the FDA (\$5,000) to act as the fiscal agent for DPH.

M. Moore reports that the "Food Plan Review Course" is being organized between the DPH and the FDA. Also, the FDA course "Special Processes in Food Procedures "was well attended and regarded.

L. Bethune is working on the interface problem and is hoping to have a "demo" ready for the December Meeting.
