Questions from Q&A answered out loud:

Brief updates: [ABCC Advisory on Musical Performances at Licensed Establishments](#) (sent before webinar). Singing is not permissible indoors. Over the weekend, the screening form did come in as well as the standing orders for J&J. Will send information after the call.

Stop the Spread program: Extended through June 30, 2021. Contracts for these are renewed every 3 months, was supposed to expire end of March.

MA Travel Order Revision re: People Completely Vaccinated: Individuals who have received two doses of either the Moderna or Pfizer or single dose of J&J vaccine more than 14 days ago, and do not have symptoms, do not need to obtain a negative test prior to traveling and do not need to quarantine upon arrival to MA. Individuals who have recovered from COVID-19 also do not need to quarantine—no specifics on variants. Vaccinated individuals arriving in MA must have documentation of their vaccination(s), including the date(s) of administration, available if asked. This exception does not include vaccinated individuals who have symptoms of COVID-19, who must follow all testing and quarantine guidance outlined in the travel rules.

Q: Travel order always exempted children under the age of 10. Has this changed?

A: Nope.

DESE In-person learning guidance: In our guidance we recommended that students wear masks, and now in new guidance we are saying they *must* wear masks. Elementary school

phase, grades K-5: Hybrid and remote learning models will no longer count towards meeting the required student learning time hours as of Monday, April 5th, 2021. Learning model for elementary school grade levels to full-time, in-person instruction five days per week effective Monday, April 5th, 2021. Middle school phase, grades 6-8: Hybrid and remote learning models will no longer count towards meeting the required student learning time hours as of Wednesday, April 28th, 2021. Learning model for middle school grade levels to full-time, in-person instruction five days per week effective Monday, April 28th, 2021. High school phase, grades 9-12: DESE will announce the details and timing of the high school phase of the plan in April. Districts will be provided with at least two weeks in advance of the date for high school students to return to full-time, in-person instruction, but should start making such plans now.

Q: Guidance for proms?

A: Working on updating this. We recommend looking at guidance we put out last year to start your planning. You could also look at [guidance for special events](#), that are not prom related, but a lot of this is still applicable.

Q: Does a waiver for a group of students with special reasons to remain at home exist? Any science to why 3ft distancing?

A: Districts are required to survey parents. Part of this is to understand which parents are going to choose to have their students learn remotely. This is still an option until the end of the year. Students who are in a hybrid model can also choose to go remote as well. If you go through the footnotes of the guidance there are references to the 3ft guidance.


Q: Flag football guidance for middle schools?

A: The guidance regarding sports is not DESE guidance, comes from EEA. There is a link on the website that has joint guidance from MIAA.

20 Communities Equity Outreach Initiative: Combining [CDC's Social Vulnerability Index \(SVI\)](#) as well as case rates of COVID-19 in communities, and giving each equal (50%) weight, helped identify potential "high need" communities in MA. Analysis done in Fall 2020 by McKinsey in collaboration with external Vaccine Advisory Group. Method uses county level SVI and city-level case rates. List prioritizes 40% of all communities in the Commonwealth (picture on next page). List includes cities where case rates may be driven by congregate care sites, which have been prioritized within the phases of the vaccine deployment.

Three goals of the initiative:

- 1) Increase trust in the vaccine's safety and efficacy, acknowledging that in many communities of color, mistrust and hesitancy can stem from a history of medical mistreatment.
- 2) Identify and reduce barriers in communities for accessing the vaccine for those who are eligible and ready to receive the vaccine.
- 3) Facilitate strategic allocation to priority populations, through existing sites as well as leveraging mobile vax options.

DPH Liaison: As part of the outreach, DPH Community Liaison will work to leverage and coordinate state resources and customize a menu of options to be offered to each community, which may include:

- Identifying gaps and mapping available resources to reduce barriers to vaccination.
- Coordinating and supporting key stakeholders to maximize and align efforts, while synchronizing outreach, working closely with LBOH, local community and faith based organizations (FBOs), CHCs, and CHWs who can support grassroots outreach to priority populations.
- Developing population specific outreach activities and engagement strategies to help increase vaccine confidence.
- Deploying DPH vaccine ambassadors to provide support for town-halls and other community forums to share information and materials, including a [DPH forum guide and toolkit](#).

-Disseminating culturally appropriate translation of campaign materials, including the "[Trust the Facts, Get the Vax](#)" campaign and vaccine FAQs in multiple languages.

-Hiring local residents to provide "boots on the ground" for neighborhood and local businesses outreach, which may include a door-knocking campaign to provide information and answer questions about vaccine efficacy and safety.

Q: Can the materials being developed be used in communities not listed in the 20 prioritized? Materials could be used to target disproportionately affected neighborhoods.

A: Resources we are developing can definitely be shared within the 20 communities and beyond. A lot of the communication materials are already on the website.

Vaccine clinics in partnership with senior affordable housing: All residents and staff of public and private low income and affordable housing are a priority population and are eligible for vaccines. Includes both public housing operated by Local Housing Authorities and age-restricted rental housing owned by private landlords who receive state/federal funding to ensure housing was affordable to low-income older adults. *Not all senior housing meets the definition of senior affordable housing used for the vaccine rollout.*

Step 1: Housing Agency (HA) finds a vaccine provider (VP) and completes the Planning Survey. HA is doing outreach now to different VPs. Once a VP has been identified, the HA must complete the [online planning survey](#). One survey should be completed for each planned clinic. Survey includes contact information for both the HA and VP as well as the VP PIN, and estimated number of doses to be needed, first and second.

Step 2: Plan and prepare for the clinic. The VP and HA should discuss how to accommodate residents who may be unable or unwilling to visit the common area for the clinic (including homebound individuals). Also need to discuss how to budget time to visit apartments for vaccination and the 15 min observation period. Protocols should be developed for how to manage residents/staff who may be anxious about getting the vaccine.

Step 3: You as the VP do not need to fill out the MCVP survey. State reviews the Housing Planning Survey responses and puts them in a queue for vaccine. Due to limited vaccine, not every HA will be able to receive vaccine allocation each week. Moderna will be used for this group. Requests must be made in increments of 100, and will be rounded to minimize waste (e.g. request for 115 doses will be rounded down to 100). The VP must have met the 65%/85% threshold for distribution of previously allocated vaccines in order to get additional vaccine allocated for senior affordable housing. Allocation timeline and process:

Monday—state contacts those VPs identified in the Housing Planning Survey who have been prioritized for that week's upcoming order. VP must complete a Google Form by noon on Tuesday confirming the amount of vaccine needed. VP should consult with the HA when completing this Google Form. VP should check in with HA "What do you think the take-up rate is going to be?"

Friday—When the order is put in, the VP will receive an automatic email from DPH. You have been approved for vaccine, but it doesn't differentiate about senior housing. You will receive a second email that says part of that vaccine allotment will be going to senior housing.

Following Monday-Wednesday—doses arrive at VP.

Within 10 days following receipt of the vaccine—clinics should have been held in the senior affordable housing properties.

As not every HA is allocated vaccine each week, no clinics or appointments should be finalized or advertised until the VP received the DPH order confirmation.

Step 4: Once DPH has approved vaccine request, HA and VP should finalize date and time of the clinic (make sure to build in time for lunch/breaks for volunteers and staff); confirm staff and volunteers; review and finalize logistics (e.g. what supplies will BP bring related to PPE, thermometers, etc); notify residents and schedule appointments (remind residents to bring ID and glasses, wear loose clothing/short sleeves); organize and obtain materials needed for the clinic. The VP and HA must develop a plan for any opened vials and any unsured vaccine that may be available after the clinic. Try to use them for residents in other senior affordable housing buildings who are 65 years or older, have two or more comorbidities, or meet other eligibility criteria. Try to use them in another senior housing clinic if one is scheduled within 10 days of receiving the vaccine. If no clinic is scheduled within that time frame, plan to use the extra doses to vaccinate other individuals who meet the current eligibility criteria as set by the state. Work with the local COA and Elder Service Agencies to identify older adults who have not yet been able to schedule a vaccination appointment.

Step 5: Receive 2nd doses and organize the 2nd clinic. At the first clinic, each person vaccinated should receive an appointment for a second dose (either 21 or 28 days, depending on the vaccine). Appointments can be made for second doses even if the VP does not have those doses available at the time. VPs do not need to and should not save first doses in "reserve" to use for second doses. Second doses for senior affordable housing will be sent automatically—VPs are required to complete the weekly Google Form to confirm their second dose needs. Vaccine requests for second doses are prioritized each week as long as VPs are meeting the 65%/85% threshold.

For help, contact seniorhousingvaccine@mass.gov. Support includes: helping HA find VPs. Answer questions about vaccine allocation process. Assist in finding local volunteers to help at clinics. Troubleshoot issues that arise. MCVP providers who have never received/requested vaccine before should contact seniorhousingvaccine@mass.gov to get assistance.

Q: Ordering second doses, do VPs order through HA?

A: VPs shouldn't do anything. You are scheduled for 4 weeks later. Senior Housing will reach out when it gets closer to that time to confirm if those doses are still correct.

Q: I haven't received the survey but we have been doing senior housing.

A: If you've done a senior housing clinic, and did not receive doses through the process laid out today, email seniorhousingvaccine@mass.gov ASAP. Some people started doing senior housing before this program started, so we might not be able to see or know that those vaccines have been done.

Regional collaborations: Subject to vaccine availability. There is obviously a concern about planning, you probably heard that small amount of vaccine can be utilized by the regional collab at their discretion, up to 25%, to use it locally in their regional area (i.e. seniors). 75% still has to go to the public. This is new as of Friday.

Educator vaccines/child care workers: Educators=K-12 school staff (teachers, any other staff). Higher education is part of Phase 3. Licensed child care workers and staff that work there (not nannies, babysitters, school volunteers) are also eligible. Vaccinating educators is a federal directive, approximately 400k individuals work in education or childcare. Massachusetts did not receive any more vaccine to support this directive. No increase in allocation for providers, and no new providers added to do this work. CVS has been identified as a participating pharmacy provide by the federal government, and they will be setting aside vaccine for educators. This does not go through DPH at all. At least a month for eligible residents to get the first dose of the vaccine. Moving the vaccine as quickly as we can. Educators are urged to book appointments through mass vax finder when they become eligible. All of the providers receiving vaccine allocation from the state are listed as open. Must serve all eligible residents at all times.

Q: Will there be any specific days set aside for educators?

A: More information to be released tomorrow about the individual days.

Q: Will there be new opportunities for municipal operations to support this targeted effort?

A: Generally, no.

Homebound: Distributed the guidance document to support this work to primary contacts of health departments on Saturday. In the resource doc there is a link to the Google survey. This is a way to indicate to us whether or not your health department or municipality wants to do homebound vaccine in-house or if you want to work with the state vendor. We do need to have a response back by March 12th. We are trying to use J&J for this work. We understand that this

will be challenging for everyone. This also means that the state vendor won't start vaccinating until J&J comes into Massachusetts, expected for April.

Q: Any particular allocation set aside for homebound?

A: No.
