Announcements:

FEMA funeral assistance benefit program: Included in the American Rescue Plan Act of 2021. Program began accepting applications for its Funeral Assistance Program on April 12th. Amount one can receive is \$9,000 per funeral, and a maximum of \$35,000 if applicants have more than one death in the family. Massachusetts has created <u>a funeral assistance page</u> where information can also be found if you need access to a death certificate and how to amend one. Example, someone passed early in the pandemic and did not have COVID-19 as a cause of death, but they did die from COVID-19. Recreational Camps: Updated standards replaced the document issued in early March. The specific cohort requirement is removed, and there is now a strong recommendation to limit group sizes. Masks not required outdoors; unvaccinated individuals advised to continue to wear face coverings indoors. Testing no longer required for overnight camps, recommended if they intend to allow unmasked, unvaccinated individuals indoors.

Moves most standards to "Advised Best Practices". Mandates are generally in line with requirement in the Rec. Camp Code (105 CMR 430) and Reportable Disease Requirements (105 CMR 300).

Q: YMCA camps, still required to have 2 nurses to check in the day campers?

A: There was a requirement last summer that everyone entering the camp needed to be screened, but this is now a recommendation. Camps must have 2 healthcare supervisors, and



these individuals can be physicians, PAs, NPs, nurses, someone over 18 years old with some medical skill. **Q:** Distancing requirements at overnight camps?

A: No.

Reopening Massachusetts: Massachusetts is on track to meet the goal set in December to fully vaccinate over 4 million people by the first week in June. The Commonwealth leads the nation in vaccinating residents, with 75% of adults receiving at least one dose. To date, over 4 million residents have received a first dose, with 3.2 million fully vaccinated. Around 92% of people are returning to get their second dose. New cases have dropped by 89% since January 8th. COVID hospitalizations are down 88% since January 1st, and the positive test rate is down by 88% from peaking at 8.7% on January 1st to 1% today. These metrics have allowed the Commonwealth to lift all restrictions on May 29th, and lift the State of Emergency by June 15th. All industries will be open, and capacity will increase to 100%. ALL COVID-19 restrictions (besides the face mask restrictions) will be lifted. This includes the distance between tables at restaurants, and social distancing requirements. Industries are encouraged to follow CDC guidance for cleaning and hygiene protocols.

Face covering guidance: Face coverings still mandatory for all individuals on public and private transportation systems (federal law), in healthcare facilities, and in other settings hosting vulnerable populations, such as congregate care setting (nursing homes, homeless shelters, correctional facilities, more info here). Non-vaccinated people are advised to continue wearing face masks and to continue distancing in most settings. Face coverings will also remain required indoors for staff and students of K-12 schools and early education providers. Businesses can still set face mask requirements.

<u>Youth and Amateur sports Face Covering Guidance</u>: May 18th, no longer requires face coverings for youth athletes 18 years and under when playing outdoor sports. On May 29th, all youth and amateur sports restrictions will be lifted. Spectators are not required to wear face coverings if they're outdoors and able to socially distance.

Q: Face coverings in public meetings?

A: If you're outdoors and able to socially distance, you do not need to use a face covering. On May 29th, you do not need to wear a face covering. If your municipality wants to require face coverings, this would be a local action taken by municipal leadership.

Q: COVID safety plans?

A: If submitted before May 29th, then yes, they should be reviewed. But no State requirement.

Vaccine updates: Pfizer now approved for 12-15 year old (Moderna and J&J should only be used for 18 years and older). Additional updates (<u>CDC page</u>), standing orders and vaccine administration preparation summary, co-administration with other vaccines, vaccinated people who subsequently develop COVID-19 disease, people with a history of thrombosis or risk for



thrombosis, use of aspirin or anticoagulants, people vaccinated outside of the United States, and Appendix A: Errors and Deviations Table.

Contact Tracing Questions:

Q: What is the protocol going to be for schools, will students who are within 6 ft and not wearing masks (outside) going to need to quarantine or not?

A: <u>DESE released an updated FAQ</u>, and in the FAQ it says that close contacts exposed to a COVID-19 + individual while outdoors at recess do not need to quarantine.

Q: What is the status of the CTC, when will their contract run out?

A: CTC contract will continue to September, but are reviewed in 3 month increments and at that time will be reviewed if continued assistance is needed.

Schools Questions: Unless DESE tells you that things have changed, they have not changed.

Q: Are masks still required for outside singing/band?

- A: No need even if distance cannot be maintained.
- **Q**: Will guidance for proms and graduations change too?

A: Guidance will be issued soon.

Q: If we hold a senior night off of school property in June, do we follow the guidelines set forth for an indoor event? Because it is school sponsored, do the students still need to be masked and maintain social distancing?

A: After May 29th, restrictions will be lifted if the event is off school property. If there are any restrictions set by the event venue, people will need to follow those. All limits/sector specific guidance will be lifted on May 29th

Q: Masks still required for school buses and transport for sports and recreational programs? **A**: Yes.

Questions from Q&A answered out loud:

Q: Does the State of Emergency being lifted affect who can give vaccines?

A: Will loop back.

Q: On Page 2 of the press release under <u>Face Covering Guidelines</u>, the end of the second paragraph mentions "certain situations". Can you clarify that and what could be some examples of this?

A: Details on the website.

Q: Can virtual meetings continue past May 29th or June 15th to be in compliance with OML? A: Should be in person, but Mass Municipal Association is trying to fix this legislatively because it's been such a success, and meeting participation has increased because of this option. Another piece that is concerning is how to meet the quorum. Lieutenant Governor made it clear that she's looking to find a fix.

Q: What, if any, restrictions will still be in place after May 29th?



A: DLS is going to rescind COVID related regulations, and all restrictions on industries are lifted.

Q: Will outdoor dining be extended?

A: In order for it to continue, local bylaw or ordinance will have to be amended. The timing of this is challenging, because would need to be done within next 2 months, and unless you're hosting a special town meeting, it would be very difficult to "fix it" locally. Mass Municipal Association is looking at trying to fix it legislatively. The Administration appears willing to support this process, or at the least not oppose it.
