**Mosquito Spraying Opt-Out Extension:** Dr. Brown announced that the Executive Office of Energy and Environmental Affairs is extending the mosquito spraying opt-out application deadline to the end of the day on Friday, May 28<sup>th</sup>, 2021. The opt-out contact information is EEAopt-out@mass.gov and links will be shared after the webinar.

**Reopening Changes:** Updates provided by Michael Flanagan; changes will be effective May 10<sup>th</sup>, 2021.

- Subject to Public Health Data, some Phase IV, Step 2 businesses and activities will be allowed.
- Amusement parks, theme parks, and outdoor water parks may re-open at 50% capacity and must submit COVID-19 safety plans to DPH.
- Road races and other organized athletic events will be allowed, and COVID-19 safety plans must be submitted as follows:
  - Submitted to DPH if the event is across several municipalities (e.g. Boston Marathon)
  - Submitted to local health department(s) if the event covers 1-2 municipalities
- Indoor/outdoor stadiums and arenas will move from 12% to 25% capacity (large venue standards).
- Singing indoors will follow the theater and performance venue standards (allowed in restaurants subject to distances, and other separations in the performance standards).
- Parades, Festivals, and Agricultural Festivals:
  - o The 50% capacity restriction is removed.
  - All parades, festivals, and agricultural festivals are required to submit safety plans to the Local Board of Health.
  - Safety plans must include measures for maintaining social distance, as well as staffing and operations plans, hygiene protocols, and cleaning protocols.
  - Parades, festivals, and agricultural festivals will be permitted as of May 29<sup>th</sup>, pending public health data.
- Retail: The senior hours requirement is removed. Grocery stores and retail stores with a
  pharmacy department <u>should consider</u> dedicated hours of operation for adults 60+ but
  will no longer be required to offer these hours.

Homebound Vaccination Program: Updates provided by Anna Dunbar-Hester.

- As of May 4<sup>th</sup>, a total of 1,184 people have been vaccinated by the state program. Of those, 934 were homebound individuals, 222 were family members, and 27 were vaccinated to prevent wastage.
- Just over 5,200 people have been identified as eligible for the state program, with 40-50 newly eligible individuals calling per day—though call volume has been decreasing substantially.
- Everyone in the queue will be scheduled by end of day today and have appointments by May 28<sup>th</sup>.
- No breakdown of vaccinations by community yet, but the vendor is working on this.
- The state program is still using the J&J vaccine, but for women under 50 who are concerned about it, there is an option to receive Moderna instead.
- Approximately 5,600 doses of vaccine have been allocated to the LBOH Option 1 communities, including approx. 1,700 Moderna doses provided as substitutes for J&J during the pause. DPH is committed to providing second doses of Moderna to those communities that switched to Moderna.
- Several communities have completed their homebound program (congratulations!) and the number of new requests for vaccine have been dwindling significantly. Requests for vaccine allocations from communities for their homebound programs will be accepted for two more weeks: request by 5pm on May 10<sup>th</sup> for delivery approx. May 17<sup>th</sup>, or request by 5pm on May 17<sup>th</sup> for delivery by approx. May 24<sup>th</sup>.
- Any remaining Option 1 communities will be switched to Option 2 effective June 1 (i.e.
  the central intake line will not refer out to LBOHs starting on that date). Communities
  can switch from Option 1 to Option 2 earlier by contacting Anna (anna.dunbarhester@mass.gov).
- A close out survey for Option 1 communities will be sent out at the beginning of June asking for a report by town of the number of homebound vaccinations performed.
- Homebound Youth ages 12-17: Expecting Pfizer to get EUA next week for ages 12+. DPH is planning on providing vaccinations to homebound youth using Pfizer's two-dose formulary. More information coming soon.


