CTC: Will continue to scale back according to need. Planning on ending services by early September. Throughout the summer. If towns are looking to hire staff, and you're looking to hire contact tracers, please reach out to your local health liaison and they can share information with their departing staff.

In-home vaccination program: In addition to the in-home vaccination efforts by the municipalities and statewide program, vaccines were also delivered in-home by some medical providers, mobile vaccination efforts, health plans, home health agencies, senior housing vaccination programs, and other that reached people in their home. Therefore, the program reporting reflected in this presentation only represents a portion of in-home vaccinations.

Total Program In-Home Vaccinations Top 20 Prioritized Communities

Equity communities were served by several additional targeted vaccination efforts including mobile vaccination teams that were not the "in-home" vaccination program; hence these numbers may not reflect all door-to-door vaccine efforts.



Q: Is contact tracing going away?

A: For the moment, case investigation and contact tracing still has a role, but this may not play as predominantly a role as it has been. We are starting to think about moving past COVID-19 being all consuming.

Q: Vaccine breakthrough cases?

A: We are seeing clusters, but they are staying smaller. This is suggestive of other data that people who are vaccinated tend to have lower viral loads. There will always be vaccine breakthrough cases.

Q: Any additional guidance for schools for the fall?

A: We will let you know as soon as it is available if any are changed from this last year.

Q: Updated information about latest J&J issues?

A: No updates on our end yet.
