<u>Week of 7/26</u>-Color and DPH Onboarding forms shared with sites. Site staff invited to attend Color training/demo (sessions will be ongoing).

<u>Week of 8/1:</u> Color Custom content form sent to sites (this allows you to include site specific information).

<u>8/13</u>: Onboarding forms sent July 26<sup>th</sup> need to be submitted by August 13<sup>th</sup> so local staff can attend the "Train the Trainer" event. This will help the local administrators train future local administrators.

<u>8/15:</u> Site trainers (Mondays and Weds throughout the summer) attend Color "train the trainer" session. Will be provided access to Fake Boston Site Sandbox Environment to get generally familiar.

8/20: Deadline for application materials in order to use Color by 9/1. Week of 8/30: Sites will be live in Color.

**Q:** Limitations—is it limited to health departments only or is this available to other clinics, ex. VNAs? VNAs also help public and private clinics, can private clinics also use Color?

**A:** If you're hosting clinics that are open and available to the public we are happy to help you set up your own account on Color, for example VNAs and School Departments. Yes, VNAs supporting private clinics can also use Color.

**Q:** Are the trainings/content information for people who are new to Color or is there additional work for those already on Color?

**A:** Color team will do separate outreach to already participating health departments. This is forthcoming, you do not need to submit the application materials. We do recommend you do attend the training sessions because there are additional features now.

**Q**: What is happening to PrepMod?

**A:** DPH has decided to contract with Color for fall flu clinics. We are phasing out of PrepMod. We encourage everyone to no longer schedule any first dose clinics after July 31<sup>st</sup> on PrepMod. If you are now scheduling 2<sup>nd</sup> dose clinics, we are reaching out to you to confirm they are 2<sup>nd</sup> dose clinics and will send out additional communication about vaccination data in PrepMod. For right now, local administrators still have access to PrepMod and the data.

**Q:** Who should we send these questions to?

**A:** If you reach out to <u>colorhelp@mass.gov</u>, we will take your questions and triage it to the right person.

**Q:** August 15<sup>th</sup> is a Sunday, is it the only day to attend the "Train the Trainer" event? **A:** This is actually the beginning of the week, so the communications will go out the week of the 15<sup>th</sup> for how to attend the trainings.

**Q:** If PrepMod is not to be used for first dose clinics now, and Color isn't active, how long do we have to wait to schedule the second dose clinics?

**A:** Submit your application as soon as possible and reach out to us at <u>colorhelp@mass.gov</u> and we can expedite your application.

### Delta variants and testing:

**Q:** Is there information to suggest that people can get the Delta variant more than once? **A:** Dr. Brown: Haven't seen data that answers that question specifically. You can definitely get COVID-19 more than once, so I think the question is if you can get the same variant more than once. I believe the answer for some of the variants is yes, and I don't know why Delta would be different.

**Q**: At home kits being sold in retail pharmacies, how are these results reported?

**A**: Many, but not all of the at-home test kits, and BinaxNOW is one of them, are integrated with some of the national reporting platforms. It comes with a QR code that you scan with your phone, and then when your test result is ready you have to scan the QR code again to view the

result. Positive test information will go to the national platform. There will be some test kits where we will not be able to record the results in MAVEN.

**Q**: Any recommendations about best practices/when it's appropriate to do this type of testing? For example, most useful for symptomatic individuals?

**A:** A little unclear at this point because they haven't been made widely available. Antigen test slightly less sensitive than PCR tests, but remain good tests. If someone is potentially exposed and they tested themselves 3 consecutive days and they're negative on all three days, then this is good news. When we were talking with our colleagues in Provincetown about how to utilize these homebased tests, couple options were to hand them out to people who are coming off the ferry or jumping onto the ferry so they could be used while the person was in Provincetown. People who are symptomatic, this is the obvious place to use them, and testing in the absence of symptoms but when there is a reasonable chance you could have been exposed.

### Other Updates:

-Extending the CTC contract until the end of the year because we understand that hiring Epidemiologists/Contact Tracers take time. Capacity right now is reduced, but as cases rise a number of municipalities are opting to use the CTC. The combination of scaling down and increasing cases has caused a backlog (4-5 days). We switched back to a surge protocol which is our best attempt to reach as many people as possible. Everyone receives a text message and a long voicemail to call the inbound line. We are trying to hire those who were phased out in July and we plan on working until November. We are also open to having conversations with LBOH to hire existing contact tracers once the CTC sunsets. If you want to take back some of your cases this can easily be done through the Local Health Liaison.

### Q: Indoor masking?

**A**: DPH issued mask recommendations based on Massachusetts data. Over 64% of total Mass population are fully vaccinated. Breakthrough cases are still really low in proportion to the numbers of who have been vaccinated. In last 90 days, less than 1% of breakthrough COVID cases led to hospitalization. All available data continue to support that the three vaccines are effective in preventing severe disease and hospitalization. People who have weakened immune systems, are at an increased risk of severe COVID-19 because of age or health conditions, or who live with anyone who is unvaccinated or at an increased risk, are advised to wear a mask or face covering when indoors and not in their own homes.
